A coordinated, comprehensive response is needed to compassionately address the needs and challenges of Kitsap's growing homeless population.

Coordination is needed at the local, state, and federal level to address the infrastructure needs of my neighbors: traffic, roads, sewer, solid waste, technology, water, schools, parks, and environmental impact.

Public Safety: We need to continue holding our law enforcement to high standards and accountability while supporting their work to protect and serve. I support expanding Kitsap's behavioral health infrastructure and navigator programs to help address the needs of vulnerable communities in crisis.

My over 20 years of experience in non-profits and education have uniquely prepared me for this role. As the Executive Director of Leadership Kitsap, I have been in the unique position to work with our community's private, public, and non-profit leaders to learn, collaborate, share resources, and create positive change in Kitsap. I know how critical safety, affordable housing, good jobs, a clean environment, and recreational opportunities are to our community.

As a Communications professor, I recognize how good communication is important to a participatory democracy. Clear, accessible, and transparent communication is vital to a functioning, representative, local government.


course of my career.
